All weddings booked with Anglia Leisure Limited shall be subject to the following:

Contract

Is between Anglia Leisure Limited and the client. Your contract with Anglia Leisure Limited is made once you have completed a booking form and paid the deposit.

Deposit

A provisional booking will be held for 14 days. Thereafter, a nonrefundable deposit will be required to secure the booking as follows:
Wedding reception held in Brown Boat Suite; £500

In the case where additional items are organised from 3rd party suppliers (eg; toastmaster, bands), additional deposits may be requested.

Price quotation

For weddings confirmed more than 12 months in advance, Anglia Leisure Limited reserves the right to apply any price increase up to 5% on the price quoted.

Balance payment

Final numbers must be given to the hotel two months prior to the date of the wedding. Guest numbers and packages cannot be reduced more than 10% from the original quote. Thereafter, any minor changes due to illness etc must be notified in writing to the hotel immediately. On receipt of final numbers the hotel will issue an invoice, full settlement of the invoice must be paid to the hotel, and cleared funds received two months prior to the date of the wedding.

Cancellations

By us

Anglia Leisure Limited may cancel bookings under the following circumstances:

- If the booked hotel or any part of it is closed due to circumstances outside its control.
- If the client has not settled the balance payment by the required settlement date.
- If it might prejudice the reputation or cause damage to Anglia Leisure Limited.

By you

If you have to cancel your booking you must telephone the hotel immediately when the reason for cancellation occurs. You must also confirm your cancellation in writing, and cancellation will become effective from the day we receive written notification. We will issue a confirmation of cancellation detailing cancellation charges.

The client will be liable for any loss or damage to any of Anglia Leisure Limited properties including walls, light fittings and equipment, and shall indemnify Anglia Leisure Limited against any loss or liability caused by the client/ and or the clients guests.

The client is advised to consider arranging insurance for the wedding covering public liability and loss or damage at its property and that of persons attending the wedding.

General

- Anglia Leisure Limited will take all reasonable steps to fulfil the reservation to the best of its ability and in accordance with the details provided. However, it reserves the right to provide alternative services of at least an equivalent standard at no additional costs to the client.
- The client shall not be entitled to assign the booking to any third party nor utilise the hotel's facilities, other than for the purpose stated in quotation letter, without prior written approval from Anglia Leisure Limited
- Anglia Leisure Limited reserves the right to pass on to the client any additional cost for disbursements made on behalf of the client in respect of good services and if required substantiated with a suppliers invoice.
- Whilst the company has taken all reasonable steps to ensure that the information contained in its brochures, tariffs, leaflets and advertisements is accurate, it reserves the right to alter, substitute or withdraw any service, facility or amenity without notice if necessary.
- Notwithstanding anything contained in these terms, the company will not be liable for any failure to perform its obligations to the client in whole or part as a result of any of the following circumstances: Industrial Action (including Strikes), Fire at or near the hotel, civil unrest, dispute or commotion, act of God, legal action against the company, not resulting from its negligence preventing the supply of services.
